THIS COURT ORDERS THAT:

1. The Respondent, Nadim Ghaznavi shall pay child support to the Applicant, Tara Evans, for the benefit of Hailey Clare Maria Ghaznavi born on February 15, 1999 and Madeline Phoebe Michelle Ghaznavi born on October 2, 2000, commencing November 1, 2013, based on an annual income of \$75,000.00 in the amount of \$1,105.00 per month.
2. That unless this Order is withdrawn from the Office of the Director of the Family Responsibility Office, it shall be enforced by the Director and amounts owing under the Order shall be paid to the Director, who shall pay them to whom they are owed.
3. This Order bears interest at a rate of 3% per annum, effective from the date of this Order. Where there is default in payment, the payment in default shall bear interest only from the date of default.

4. For as long as child support is paid, the payor and recipient, must provide updated income disclosure to the other party each year within thirty days of the anniversary of this Order as per Section 25.1 of the *Child Support Guidelines*.
